- NO ADDITIONAL CHARGE FOR THE ADDING ON OF GUESTS IF THE TIME ALOTTED IS AVAILABLE, HOWEVER, ADDITIONAL GUESTS WILL BE CHARGED THE FULL AMOUNT FOR THE SERVICES THEY HAVE COMPLETED.

ON-SITE PARTY

- PLEASE MAKE SURE TO FILL OUT ADDITIONAL INFORMATION FOR ON-SITE BRIDAL PARTIES.
- TRAVEL COSTS ARE IN ADDITION TO TOTAL SERVICES RENDERED.
- LOCATIONS WITHIN 30 MILES OF THE SALON WILL BE CHARGED A TRAVEL FEE OF \$150.
- LOCATIONS OF 30 MILES OR MORE FROM THE SALON WILL BE CHARGED A TRAVEL FEE OF \$200.
- TRAVEL FEES ARE PAYABLE BY CHECK, CASH OR CREDIT CARD FOUR (4) WEEKS PRIOR TO YOUR EVENT DATE.

STANDARD TERMS AND CONDITIONS

- In order to reserve Renew Salon and Spa staff for a wedding date, the bride must sign this Bridal Agreement and pay the nonrefundable retainer. By signing this agreement, the bride agrees to be legally obligated to all the terms herein. This agreement is only valid after execution of this Agreement by Renew Salon and Spa.
- Pricing reflected in this Agreement is guaranteed for 14 days from our first contact about your wedding date. If this Agreement is changed or updated, or pricing changes after such 14-day period you will need to enter into the then-current Agreement to retain the services of Renew Salon and Spa.
- In order for Renew Salon and Spa to properly service your bridal party, Renew Salon and Spa requires a final count 4 weeks prior to your wedding to review the final schedule.
- In order for Renew Salon and Spa to complete your bridal party services in a timely manner, it is absolutely necessary that everyone be ready at their prearranged times. This includes all guests arriving with clean, dry hair. There will be a 15-minute grace period for the arrival time of the party, every additional 30 minutes will be subject to a \$25 fee. Please be conservative with time when scheduling your wedding day activities.
- In the event of cancellation of the wedding, the Retainer and all payments received to date shall be retained by Renew Salon and Spa and shall be non-refundable in all respects. Clients shall provide Renew Salon and Spa with at least three (3) weeks' notice prior to any cancellations of the wedding. In the occasion of a cancellation in less than three weeks' prior, the client is required to pay 50% of the total services scheduled, in the event of a "no show"
- In the event of postponement of the wedding, the Retainer and all payments received to date shall be retained by Renew Salon and Spa and shall be non-refundable in all aspects. Clients shall provide Renew Salon and Spa with at least three (3) weeks' notice prior to any postponements of the wedding. In the occasion of postponement in less than three weeks' prior, the client is required to pay 50% of the total services scheduled.
- By signing this Agreement all parties agree to and acknowledge the style of services performed by Renew Salon and Spa Staff. No refunds shall be made for services and goods provided based upon the client's dissatisfaction with such style of services.
- Notwithstanding anything contained in this Agreement to the contrary, the client's sole remedy for an actual breach by Renew Salon and Spa of its obligations under this Agreement, shall be termination of this Agreement and a refund of the Retainer and other monies collected hereunder up to the date of such breach or, at Renew Salon and Spa's option.
- In no event shall this Agreement be modified, altered or amended without the prior written agreement of each party hereto.
- This Agreement supersedes all prior agreements, representations and understanding between the parties (whether written or oral) with respect to its subject matter and constitutes (along with the schedules attached hereto) a complete and exclusive statement of the terms of the agreement between the parties with respect to its subject matter.
- If any provisions of this Agreement is held invalid or unenforceable by any court of competent jurisdiction, the other provisions of this Agreement will remain in full force and effect. Any provision of this Agreement held invalid or unenforceable only in part or degree will remain in full force and effect to the extent not held invalid or unenforceable.
